

**BEARS FIT WORKOUT AND WIN DRAWING  
OFFICIAL RULES  
NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** The Bears Fit Workout and Win Drawing (“Drawing”) starts Saturday, February 5, 2020 at 7:00AM Central Time (“CT”) and ends on Saturday, February 29, 2020 at 7:00 PM CT. To enter the Drawing, complete one of the following: (1) workout at Bears Fit; (2) bring a first-time guest to Bears Fit; (3) burn a personal training session with a Bears Fit coach at Bears Fit; and/or (4) take a Bears Fit group fitness class at Bears Fit and complete the entry form by providing your name, email address, and phone number.

**2. ELIGIBILITY:** The Drawing is open to all legal residents of the United States ages 18 years and over as of February 5, 2020, unless prohibited in the state.
